Board Meeting Minutes July 12, 2021 – 6:30 PM

Pledge of Allegiance

Public Comments:

 Gale O'Donnell asked if CSX is doing anything to address the noise problem with the inland port loading and unloading of cargo trailers as well as the increase in tractor trailers driving from the train yard.

Mayor Tackman responded that he had not heard back from CSX about ways to reduce the noise, but they said that it would take some time.

Gale O'Donnell asked if the Village would contact Senator Schumer and other local politicians to speed this up.

Mayor Tackman said that he would contact Senator Schumer's office and the others.

- Sonia Ranger expressed that she wanted to see more police presence in the village. Also concerned with people not stopping at the stop signs. Concerned about teens walking late at night throughout the neighborhood.
- Steve Russell expressed that he too was concerned with people driving through the stop signs, cars parking all over the road on both sides, and having to listen to the language coming from nearby homes. In the past five years, he said, the Village is going down and getting worse.
- Robin Evelin talked about neighborhood watch program, that they would be holding more meetings. The mayor expressed that they can use the building anytime to hold a meeting
- Other residents that were present also expressed their concerns with drugs being openly sold near schools and drugs being sold in the Village.
- Captain White from the Dewitt police explained that the call volume within the Village has stayed about the same over the last few years. He will be providing the Village monthly reports on call volume specifically from the village. The highest call volume is from the Walmart store. He explained to the residents that they would address some of their concerns.

Discussions:

1. Public Safety ideas

• The mayor informed the residents that a committee has been set up to meet with the DeWitt police to try to improve the relationship between the police and village residents. Some of the suggestions were developing a joint marketing plan to improve understanding between the police and residents, having more officers more visible to the residents knowing the children, and officers making time to meet with Village families and youth.

2. Email/website domain option with .gov

The board does not see any benefit to change the Village's domain name to .gov.

3. Cannabis Legislation update

The Village has by November of this year to decide if they want to opt in or opt out of the cannabis legislation. If the Village decides to opt out they cannot go back and opt in. This process to opt in will take a year or more to get all of the legislative regulations in place. It will be controlled similar to the alcohol sales license. But again the State has not fully outlined how this program will work.
