Public hearing - West Terrace St. zone change.

Residents Comments and Questions:

Resident 1: I own a house in 2 adjoining properties. Both of my vacant lots are commercial. The business that started all this is commercial. What is the rezoning if everything is already commercial?

Codes Officer Shields: When we have a zoning on the map the entire block gets zoned the exact same way. It doesn't matter if it's a residential house or a commercial building. In 2007 is when they rezoned the entire Village and they got rid of several zones and they made all of West Terrace St. main street zone as well as West Manlius St. and East Manlius St. Our main street zone is our strictest zone for obvious reasons which is not odd to have your main drag going through a small village be your strictest zone. The problem that we're having is that 80% of main street zone is commercial property and directly across the street is industrial railroad tracks. It's very difficult for the property owners because it limits them to what they can actually do with the property due to the railroad tracks directly across the street.

Clerk Moracco: Does the zone change benefit the residents with either the sale of their home or what they can do with their property?

Codes: It all depends on what the person buying the property wants to do. However, it does open up a whole other category so if you want to sell your house and a business wants to come in and build a business on your property you have the option of knocking down your house and selling them the land.

Resident 1: If a house burns down on that street and someone wanted to rebuild a house is that allowed?

Answer: Yes, if we add West Terrace St. to the list of other street names that would fall into the same predicament.

Resident 1: If this zone goes commercial will my taxes go up as a result of this?

Codes: The Town of Dewitt does the assessing so I don't know at this time. Does anyone know if that changes anything?

Mayor Dadey: I don't believe so but I think what would be in everyone's best interest and respectfully I would like to table this conversation till the next board meeting until we can answer these questions. We will put this on the agenda for the next board meeting. Are there any other comments or questions on the topic of the zone change?

Resident 2: If it's already 80% commercial why is it zoned main street instead of commercial?

Codes: You can have commercial businesses on main street but their limited. There's a classification called main street zone but you can do more within a commercial zone than you can do in a main street zone. (Ex: If someone wants to open up an auto repair shop. Today he is able to do that but there are just a few extra hoops that he has to jump through to do that. However, if it goes to commercial zone he wouldn't have to go through those extra hoops.)
