FedEx project approved last meeting is coming along nicely. Turning into 2 stores, one side FedEx other side not rented yet.

Food Truck explosion in Cortland. The state is now working on changing codes for food Trucks. Chris will be coming to the board shortly to ask for changes in codes. Food Trucks need vending permit and health permit. Chris states they have to go through a whole permit process. State wants the vendor to have to get individual permits per municipality. Vendors want statewide ones or Countywide permits they do not want to do that. County does do inspections for vendors on County Property. Not if vendor is not on their property.

Also we will need to start looking at getting our marijuana rules in place. Right now we do not have one. We do not have to. Because it is retail our codes work. The board should decide if we want to keep as is now or if they want to make more strict rules. 95% of the Village can sell today going from State Law. One thing to think about is do we want to create a new zone, only sell residential or commercial.

### FIRE:

Minoa has a new chief. They will be coming to the village running drills and doing more work with our department when they are staffed. They have similar staffing as we do.

Wants to thank Mayor Dadey, Deputy Mayor Albanese and Clerk Sarah for showing up at their training over the weekend. They had 5 different departments there. Cut up 20 cars in 2 days. Positive comments regarding political entities showing up and supporting the fire department. Not normally the case. Deputy mayor commented on how interesting it was to see the training. Mayor Dadey commented on how important it is for the training they were doing with the highway traffic issues coming up with I-81 etc.

Deputy Mayor Comments: The fire training was really awesome and she has heard good things about the Fall Festival. Everyone had a really good time.

Trustee Celletti: he has to resign as a budget officer as the meetings are effecting his work schedule.

Mayor Dadey: Advised that Deputy Mayor Albanese, Clerk Sarah and Deputy Clerk have been working on keeping track of the budget with monthly meetings. Mayor Dadey thanked everyone for keeping on top of it. **Public Comments:** 

Jordan: Has questions re: McCool – Drainage Asked when the village is doing a Drainage assessment. Deputy Mayor will contact Randy and get an answer for him. Randy is at a conference at this time.

Jimmy has concerns regarding the sidewalks. He feels that there are pipes either National Grid or OCQWA. He think the Village is responsible for paying for all of the sidewalk repairs.

Mayor Dadey advised it depends on who destroyed it. The Village pays for half sidewalk repairs and if the cause was a tree they Village does pay for 100%.
