Mayor Dadey: Motion for the adoption of the proposed General Code Book.

In accordance with Subdivision 3 of § 20 of the Municipal Home Rule Law, the local laws, ordinances and certain resolutions of the Village of East Syracuse, as codified and consisting of Chapters 1 through 340, are hereby approved, adopted, and enacted as the Code of the Village of East Syracuse, hereinafter referred to as the "Code". The provisions of the Code, insofar as they are substantively the same as those of local laws, ordinances and resolutions in force immediately prior to the enactment of the Code by this local law, are intended as a continuation of such local laws, ordinances and resolutions and not as new enactments. This local law and the Code adopted hereby shall supersede and replace the 2003 Code of the Village of East Syracuse, as amended and supplemented.
