 1. Comparison to last year the budget is a **\$209,370** decrease.
 2. Revenues are **\$2,047,424** and **\$1,958,238** to be raised through property taxes.
 3. Revenues from non-property tax sources include: payments in lieu of taxes, interest earnings, fees, court fines, franchise fees, fire protection contract, CHIPS, county payment to support Village infrastructure, state aid and grants.
 4. New General fund tax rate will be **9.88 / 1,000**.

- ii. Mayor Tackman presented the details of the Sewer fund budget for 2019/2020:
 1. Comparison to last year the budget is a **\$10,564** decrease.
 2. Revenues are **\$200,000** and **\$125,795** to be raised through property taxes.
