- 1. A plot plan showing location of FENCE on a current survey and a complete set of specifications must be made a part of this application. Plans and specifications shall describe the nature of the work to be performed and the materials and equipment to be used and installed. Three sets of plans must accompany this application. Work conducted pursuant to a building permit must be visually inspected by the Code Enforcement Office and must conform to the New York State Uniform Fire Prevention and Building Code, the Zoning Ordinance of the Village of East Syracuse, and all other applicable codes, rules or regulations.**
- 2. OWNER HEREBY AGREES TO ALLOW THE CODE ENFORCEMENT OFFICE REPRESENTATIVES TO INSPECT THE SUFFICIENCY OF THE WORK BEING DONE PERSUANT TO THIS PERMIT, PROVIDED HOWEVER, THAT SUCH INSPECTIONS(S) IS (ARE) LIMITED TO THE WORK BEING CONDUCTED PURSUANT TO THIS PERMIT AND ANY OTHER NON WORK-RELATED VIOLATIONS WHICH ARE READILLY DISCERNIBLE FROM SUCH INSPECTION(S).** New York State law requires contractors to maintain Worker's Compensation and Disability Insurance for their employees. No permit will be issued unless currently valid Worker's Compensation and Disability Insurance Certificates are attached to this application or are on file in the Village Office. If the contractor believes he/she is exempt from the requirements to provide Worker's Compensation and/or Disability Benefits, the contractor must complete C-105.21, attached hereto.
- 3. This permit does not include any privilege of encroachment in, over, under, or upon any village, county or state street or right-of-way.**
- 4. The building permit card must be displayed so as to be visible from the street nearest to the site of the work being conducted.**
