- **Marijuana Legalization Update**

We need to decide if we will allow the sale of Marijuana in the Village. There are two types of licenses that the State will be given out. Municipalities will receive % of tax. The Village will need to decide by the end of the year if they allow the sale. A referendum and Local Law change would be needed by August.

- **Main street Grant Update**

Mayor Tackman went over the information that was given to him from Community development.

- **Flags for Hero's program**

Asked the Board if there was any interest he would like to see this program implemented. The Village would pay for the hangers and residents would buy the flag. It would hung up for a number of years. The mayor was going to talk to companies that sale the flags at the NYCOM conference and will provide that information back to the Board.
