Amending Resolution regarding partial payments of the Village real property taxes whereas by resolution

no. 37-1995 this legislation authorized village collection officers to accept partial payments of village real property taxes, special, actable on levies and assessments and whereas in these difficult economic times, many residents of Onondaga county are finding it difficult to budget real property tax payments according to the existing schedules established in such resolutions and whereas when a resident is unable to make conforming payments the municipality is negatively affected because it misses out on having cash in hand and the resident is negatively affected because the statutory interest on penalties accruing on the outstanding balance. And whereas it is necessary to amend the prior resolution so is to provide residents greater flexibility in making partial real property tax payments in amounts other than 50% of the total tax due for each of the 3 permissible instalments.

Now therefore be it resolved that Resolution No. 37-1995 is hereby further amended to allow partial payments of Village Real Property Taxes, special ad valorem and special assessments as shall be consistent with the following:

- 1. The Village real property taxes, levies and special assessments may be paid in up to 4 partial payments during village collection period of the then current tax year.
- 2. The initial partial payment should not be paid no later than one day of the penalty free period of the current tax year
- 3. No minimum amount is required for partial payment except the final payment shall be in the amount of remaining unpaid balance due and owing. No partial payment shall be accepted from a property owner if there are delinquent real estate taxes, special ad valorem levies and special assessments owned on such property unless the property owner is current.

- 4. Installment payments to the county pursuant to local law No. 7-1995 as be amended from time to time.
- 5. Be it further resolve that in all other respects Resolution No. 37-1995 shall remain in full force and effect.
- 6. Be it further resolve that the clerk of the legislature is directed to file a certified copy of this resolution with the commissioner of the New York State Office of real property tax services no later than 30 days after adoption. The Village Board of Trustees hereby supports this resolution and will be in the future accepting partial payments in accordance with Onondaga County Resolution No. 38 Amending Resolution No. 37-1995 regarding partial payments to the Village real property taxes.

All claims stated shall be presented at the next regular meeting for audit. This resolution was initially adopted August 5, 1996 and affirmed annually.

Whereas it is determined by the Board of Trustees that attendance by certain municipal officials and employees at one or more of these meetings, schools and conferences benefit the municipality. Now therefore be it resolved Section 1. The officers and employees authorized to attend such training.

Section 2. Approvals granted herewith acknowledge and authorize the payment of claim for any registration or program cost but not any additional expenses or charges. Such as vehicle or mileage reimbursement, overnight accommodation, meals or other out of pocket expenses. A separate and formal request must be made to the Board of Trustees for prior approval for any such additional expenses or charges.

Section 3. The Board encourages all employees to attend training locally or within a days drive to avoid adding cost for overnight accommodations whenever possible. Section 4. Whenever possible a Village vehicle should be used for all Village related travel.

<u>Mayor Dadey:</u> This should definitely be put on the to-do list. Its honor and respect and we need to make sure this is a priority so if you have to put it on the to-do list and you have to include the Veterans Park than that is what we need to do.

Randy Hughson: I usually take care of the Veterans Park because I get notifications from the state.

Mayor Dadey: Thank You Randy.

Eric Gross(Village Resident): I'm actually the one who has been fighting the Village for 3 years on this issue so for you to take this up, I appreciate it and the Veterans appreciate it. I thank you and hope that we can get somebody to take on this responsibility.

Mayor Dadey: This is in my opinion a simple ask.

Thank you Randy for taking care of it at the Veterans Park up until now.

<u>Mike Moracco</u>: We still have outstanding grant funds that are out there.

The Carl Sterling Park- The person from the state who was handling this grant has just retired and the state has not filled this spot yet so we're still waiting for \$150,000.00 which will probably be reimbursed within 2022.

The sewer grant- We realized that there were funds from years ago that hadn't been reimbursed so I sat with the state and the EFC who oversees it and we've come up with a number that will be reimbursed to us.

The Main Street Grant-

Assemblywoman Hunter's Grant- \$260,000.00 (\$80,000.00 was budgeted towards the salt shed, \$30,000.00 was to go to Bagg St. Park, \$150,000.00 was to improve some of the easy Clark St. Bridge repairs. Of that \$260,000.00, the Village has to put up 20% (\$52,000.00). We talked to Tom and asked if he has any suggestions for Bagg St. Park. We need to have a safe entrance to enter the park

Ley Creek Grant- Storm water Improvement Grant \$150,000.00 to improve the storm water runoff across Manlius St. into James St.

We need to install gabions along the banks to reduce erosion.

Fire Department-

<u>Chief Shields</u>: We've had some new members trickling in so we're looking forward to the new year and hopefully that continues.

Preventable maintenance- We are almost finished but the supply chain is making it difficult to get parts in.
