## Mayor Dadey presented the proposed General Fund Tentative Budget for the fiscal year 2022/2023, consisting of :

- a. General Fund Budget for 2022/2023:
  - Revenues \$2,232,107 and \$2,217,350 to be raised through property taxes.
  - Revenues from non-property tax sources include payments in lieu of taxes, interest earnings, fees, court fines, franchise fees, fire protection contract, CHIPS, county payment to support the Village infrastructure, state aid and grants, and
  - New General fund tax rate will be \$10.128/1000
- b. Sewer Fund Budget for 2022/2023
  - Revenues are \$0.00 and \$142,048 to be raised through property tax, and
  - New Sewer tax rate will be .606/1000.
