 - Decreasing fund A.9785.0604 \$22,191 (brush truck);
 - Increasing fund A8160.0412 (garbage contract) by \$15,000 bringing it from \$175,000 to \$ 190,000;
 - Increasing fund A.5182.0415 (street lights) \$7,191 bringing it from \$50,000 to \$57,191;

- Decreasing fund A.3620.0200 (Codes Car) \$12,000 bringing it from \$42,000 to \$30,000;
- Increasing contingency fund A.199.0430 \$ 12,000 bringing it from \$ 100,000 to \$ 112,000.

NOTE: These Changes do not affect the tax rate in the tentative budget. General fund stays at 10.128 and sewer stays at .606 for a total tax rate of 10.734
